When the competitive bid process was first introduced in early 2000, SelectCare opted into the program. After the second year, Cindy decided to move in another direction. SelectCare expanded its hospital services contracts and focused on non-Medicare patients and non-competitive bid products. Essentially, Cindy changed SelectCare's business model.

It took about a year of diligence, cost-cutting (a secondary location was closed) and building up of inventory of non-competitive bid products. The outcome was worth it.

SelectCare's Exemplary Provider accreditation helped give Cindy the tools to streamline and standardize her company's services when she needed it most. SelectCare is now recognized regionally for:

- 1. Superior customer service
- 2. Patient-centered focus
- 3. Being on call 24/7
- 4. Being "In-network" with 99% of insurance companies
- 5. Its standard practice of on–site to hospitals, rehab locations and patient homes

As part of its Exemplary Provider on-going practice, SelectCare submits quarterly patient outcomes for review, comment and any necessary remedial action. The Compliance Team offers sound counseling throughout the year, keeping SelectCare on its toes and compliant with all regulations. Cindy says it is like "having two heads in the company."

With 10 employees, a growing database of contracts and an excellent customer approval base, SelectCare will be a community leader for many years to come. ■
